

Here is a short description of the Library Advisory Review Board:

#### **Function of the Board**

The Board "shall advise the New Castle County Library Department and recommend programs concerning local library needs and the implementation of an effective county library system". The County Executive, with the advice and consent of the County Council, shall appoint (12) twelve members who shall serve for terms of three years, provided that the terms of the original members shall be established in a manner that four shall expire each year. The County Executive, with the advice and consent of the County Council, shall appoint one additional member who shall be Chairperson and who shall serve at the pleasure of the County Executive. The Board shall consist of 13 members who shall serve without compensation.

# December 14 Resolution to County Council for adoption vote of proposed Library Master Plan 2010-2030

New Castle County's Department of Community Services has put together its 20-year comprehensive master plan for the library system from 2010 to 2030.

Anne Farley, General Manager of the Department of Community Services, presented an updated version of the master plan during County Council's Nov. 23 Community Services Committee meeting.

Here's the Reader's Digest version of what the next 20 years of county libraries could look like.

#### Five new brick-and-mortar libraries

The plan calls for the construction of five new libraries in the county, with construction on the first set to begin in 2014 and the last planned to start in 2017. The largest of the planned libraries is a 25,000-square-foot facility (which will eventually be expanded to 40,000 square feet) located just below the canal. That library is expected to cost between \$13 million and \$14 million to build and is projected to set the county back \$1.2 million to \$1.4 million annually through operating expenses.

The other planned libraries include a \$4 million Middletown community library, to replace the Appoquinimink library, currently housed in a leased facility; a \$6.5 million Townsend community library; a \$6.5 million community library located on the Route 9/Route 13 corridor near New Castle; and a \$6.5 million community library near the intersection of Route 896 and Route 40 in the Bear/Glasgow area.

### A paperless library

The master plan calls for the development of a virtual library, housed physically and organizationally in the technical services department, that would provide remote services like online references, downloadable audio and e-books, public outreach through social networking and even delivery of materials to home-bound patrons.

### **Fixed library hours**

The master plan sets specific operating hours for each type of library based on size. Regional libraries (Brandywine Hundred, Newark and Wilmington) would be open 55 hours each week; area libraries (Bear, Hockessin, Kirkwood, Woodlawn and New Castle), would be open 51 hours each week; community libraries (Appoquinimink, Claymont, Elsmere, Corbit Calloway, Delaware City and North Wilmington) would be open 40 hours each week and neighborhood libraries (Garfield Park) will be open less than 40 hours each week.

#### The bottom line

The entire plan calls for \$36 million to \$38 million in new construction, as well as \$43.7 million to \$47.6 million in expansions and refurbishments to five libraries (Brandywine Hundred, Newark, Woodlawn, Hockessin and Kirkwood).

### What they're saying:

"It just doesn't appear on the surface that anyone is going to have the additional funding to provide for the additional need," said Councilman Jea Street (D-Wilmington South).

"There has to be a reality check," said Councilman Penrose Hollins (D-Wilmington North) "If you look across the country, when economic times are hard, libraries are the first to go."

#### What's next?

The Department of Community Services has posted the entire plan on the libraries website, nccde.org/libraries, and is accepting comments from the public via e-mail until Dec. 3. The department will then present a resolution to adopt the master plan to council on Dec. 14.

## PROTECT YOUR HOLIDAY PURCHASES

Commissioner Stewart Urges Delawareans to Be aware of Existing
Insurance Coverage and Store-Offered Extended Warranties Before Holiday
Shopping

**Dover, DE (November 12, 2010)** — As Thanksgiving approaches, many consumers are making their holiday gift lists and keeping an eye out for Black Friday and Cyber Monday deals, especially for items like flat-screen televisions, exercise equipment, gaming consoles and computers.

Delaware Insurance Commissioner Karen Weldin Stewart cautions that although you may be excited about bagging a bargain, but before you're asked if you want extra protection at the check-out, find out if you're already covered for damage or loss.

Stewart further stated, "Now is a great time to find discounts on popular items, especially electronics, and it is equally important to insure the investment. We should know what the existing insurance covers before purchasing additional protection, like an extended warranty."

Commissioner Stewart suggests the following tips when deciding if additional protection is needed.

#### Find out what your insurance policy already covers.

The first thing to check is your homeowners or renter's policy. Find out what household items are covered under your existing insurance and if there are exemptions. Your insurance usually protects against theft or damage, though there may be caveats about what is covered.

Commissioner Stewart added, "Many homeowners and renter's insurance policies cover electronics and other expensive goods up to a certain limit. It is important to do your research ahead of time so you make financially responsible choices at the register and avoid spending more than you need to."

The amount of coverage and the nature of coverage vary with each homeowners and renter's insurance policy. If your policy has actual cash-value coverage, you will be reimbursed for the current cost of the property at the time of the claim, minus the deductible. If you have replacement cost coverage, you will be reimbursed for the full value of the replacement item.

Know the stipulations of your policy or talk to your insurance agent before making your purchase to avoid doubling up on coverage.

Ask your agent about coverage amount limits to make sure your new purchases don't exceed your policy threshold. Certain valuables might be better covered with an insurance rider or additional policy, depending on the circumstances. Your agent can help you assess the benefits and costs when considering this option.

If you are a renter and don't have renter's insurance, you might consider this kind of protection. Although your landlord should have insurance for structural damage to the building, this coverage does not extend to your personal property. The average renter's insurance policy costs between \$15 and \$30 per month. Replacing all of your possessions will cost much more.

#### **Understand the Difference Between Insurance and Warranties.**

Part of the holiday shopping tradition is the extended warranty sales pitch at check-out. However, a warranty is not insurance and does not cover damage in the way a homeowners or renter's policy might.

A manufacturer's warranty offers a certain kind of guarantee to the quality or performance of an item for a specified time period. Some are lifetime warranties; others are one- or two-year warranties that cover malfunctions or repair needs. Warranties vary by product, model and manufacturer.

In addition, some retailers offer extended warranties that typically extend the original manufacturer's warranty or provide additional perks and services, such as in-store repair. Unlike a homeowners or renter's policy, these warranties do not cover the cost of replacing the item if it is stolen, but some will cover certain kinds of damage to the product or product malfunctions.

#### Update your home inventory.

Keep a list of electronics and other valuable household items with model numbers and receipts. As you buy, give away or sell belongings over time, your coverage needs can change. Checking your inventory regularly can help you save money or avoid being under-insured. A home inventory can also help when filing a claim after a loss.

#### **For More Information**

Commissioner Stewart concluded, "Your existing insurance policies might not cover all possible damages, but it's important to be informed when weighing the costs and benefits of additional warranties. These situations can be complicated – and often stressful when you're pressed for time at check-out – but you can always call your insurance agent ahead of time to find what options you have for protecting bigger or more expensive items."


## Volunteers Make the Difference
