# Senior Sergeant Keith Sparks Rescues Woman From Burning Car

Senior Sergeant Keith Sparks has been credited with saving the life of a 21 year old female who had crashed her car into a tree and was trapped inside while the vehicle was on fire. S/Sgt. Sparks was able to suppress the flames enough to remove the operator from the backseat of the car as parts of her upper body were on fire. He then was able to extinguish the flames on the victim who was later rushed to the Christiana Hospital where she was treated for significant burns about her upper body. S/Sgt. Sparks also sustained burns to his hand during the rescue. On Saturday (12/11) at 2:30 a.m., County Police and Paramedics responded to the area of the unit block of Chestnut Street near the intersections of Marsh and Darley Roads for a report of a single car crash. It was reported a female victim was trapped inside the car which had caught on fire. S/Sgt. Sparks was the first officer to arrive at the crash site and quickly deployed his fire extinguisher into the driver's area where the female occupant was engulfed in flames. After suppressing the fire, S/Sgt. Sparks was able to grab the operator from the back seat and pull her from the burning car. He then had to quickly extinguish the fire about her upper body including her head and face. The victim was admitted in critical condition with burns to over 15% of her upper body. S/Sgt. Keith Sparks was also treated and released for burns to his hand. S/Sgt. Sparks has fully recovered from his injury. The investigation has revealed the operator was traveling on Chestnut Street and failed to negotiate a curve in the roadway. Her 2001 Saturn left the roadway and struck a speed limit sign, a mailbox, and then a tree. S/Sgt. Sparks formally met the victim for the first time on Sunday, January 30th 2011, while at her home. It was reported that she is doing well.



S/Sergeant Sparks was recognized at the January 18th, 2011 New Castle County Council meeting for his heroic rescue.

### Officers Execute Search Warrants at a Home in Bear, Man Arrested

New Castle County Police have arrested Brian Protack, 24 year old male who resides in the 800 block of Powder Way in Hunters Run Trailer Park in Bear. He has been charged with weapon and drug offenses after officers conducted two search warrants at his home and he was found to be in possession of drugs and a firearm. Protack, who is a convicted felon, is prohibited from possessing guns. On Monday (12/13) at 9:00 a.m., a team of officers from "E" Squad executed a search warrant at the aforementioned residence, after receiving information that Protack was living at the home. Protack was wanted by the Division of Gaming Enforcement for robbery and had seven outstanding capiases. As a result of the search, officers found Protack hiding in a bedroom and he was arrested without incident. Officers also observed a baggie containing marijuana residue inside the home. During the execution of a subsequent search warrant, officers found marijuana, drug paraphernalia, two rounds of ammunition and a 9mm handgun that was located under a bed. Protack was charged with possession of ammunition by a person prohibited, possession of a deadly weapon by a person prohibited, resisting arrest and possession of marijuana. He was also charged with robbery in the second degree and other offenses from a warrant that was issued by the Division of Gaming Enforcement. He has been arraigned and committed to the Howard Young Correctional Institute after failing to post \$10,900 secured bail and \$120 cash bail.

## Man Charged with Falsely Reporting a Robbery



New Castle County Police have arrested **Ryan Quigley**, an 18 year old male who resides in the 2100 block of Willow Way in the community of Ardencroft in Wilmington. Quigley falsely reported a robbery and assault so he could get his prescription medication filled prior to the refill date. On Tuesday (12/28) at 9:35 p.m., County Police responded for a reported robbery that allegedly took place on Shrewsbury Drive near the intersection of East Boxborough Drive in the development of Ballymeade. When officers arrived, they contacted Quigley who advised that as he was walking on Shrewsbury Drive and heading to a friend's house, he was approached by two male subjects. Quigley told police that the suspects assaulted him and stole an undisclosed amount of money and a full bottle of his prescription medication. During the investigation, **Officer First Class Austin Jenkins** found several inconsistencies in the victim's statements. Further investigation revealed that the incident never occurred, and that Quigley reported the confrontation so that he could receive a police report and have his medication refilled. Quigley

was arrested and charged with falsely reporting an incident. He was arraigned and released on \$500 unsecured bond.

## Safe Streets Officers Seize Firearm During Search

The New Castle County Safe Streets Task Force has arrested Paul Hodgkinson, a 28 year old male who resides in the Villas Apartment complex in New Castle. He has been charged with weapon and drug offenses after officers found marijuana, drug paraphernalia and a handgun in his apartment. On Tuesday (12/14) at 7:00 p.m., officers from the Safe Streets Task Force responded to the 100 block of Villas Drive after receiving information that Amanda Wooters, a 28 year old female who is a level I probationer, was living in the apartment with her boyfriend Hodgkinson. Wooters was wanted on several capiases and for violating her probation. As a result, a warrant attempt and administrative search was conducted at the home. When officers arrived, they contacted Wooters, who was immediately taken into custody without incident. Officers also came in contact with Hodgkinson while inside the home. Probation officers conducted an administrative search of the residence that led to the discovery of a small amount of marijuana, two digital scales, a grinder, a .380 handgun and ammunition. The handgun was located in the hallway closet, which was inside a winter hat that was found in a child's Halloween bag. It was also learned that they have a one year old child that lives with them, who had left the home with a relative before the officers arrived. Hodgkinson was charged with possession of a firearm during the commission of a felony, possession with intent to deliver marijuana, maintaining a dwelling for keeping controlled substances, possession of drug paraphernalia and endangering the welfare of a child. Hodgkinson was arraigned and committed to the Howard Young Correctional Institute after failing to post \$20,000 secured bail. Wooters was committed to the Woman's Correctional Institute for violating her probation.

## Police Canine Apprehends Burglary Suspect

New Castle County Police have arrested <u>Michael P. Edwards</u>, a 20 year old male who resides in the 700 block of W. 28<sup>th</sup> Street in the City of Wilmington. He has been charged with burglary related offenses after he was caught inside a New Castle home that he had just broken into. Edwards was later treated and released for injuries he sustained during the canine apprehension. On Tuesday (11/30) at 1:05 p.m., County Police responded to a home in the 300 block of Oregon Avenue, in the Penn Acres

community, for a report of a burglary in progress. A concerned neighbor had called 911 after watching a male subject walk into the rear yard of the home and enter the dwelling through an unsecured window. Within moments, Officer Edwin Mousley and his canine partner "Quattro" arrived at the home as additional officers set up a perimeter outside. Quattro was deployed into the home after the intruder failed respond to the verbal

commands of the officers. Quattro searched the home and located Edwards hiding behind a bed in an upstairs bedroom. He was taken into custody after a brief struggle with the canine. At the time of his arrest, police found he was in possession of an I-Phone that belonged to the victim. A canvass of the area revealed Edwards had attempted to break into another home on the same block, but was chased off by the 74 year old female resident. Edwards was charged with burglary, attempted burglary, theft, attempted theft, and resisting arrest after he was discharged from the hospital. He was later arraigned and committed to the Howard Young Prison after failing to post \$12,500 secured bail.

# **New Castle County Police K-9 Unit**

The canine unit averages close to 4,000 K-9 calls for service per year. Last year they had 87 apprehensions, handled 472 narcotic and 65 explosives calls, while seizing \$418,385 dollars in U.S.C. sniffs. They also assisted other police agencies 297 times and were active in the community performing over sixty K-9 demonstrations.

# <u>Police Canine Tracks, Apprehends Suspect</u> Involved in Domestic Dispute

New Castle County Police have arrested **Justin** Amalfitano, a 21 year old male who resides in the unit block of Stevens Avenue in New Castle. He has been charged with felony related offenses after he assaulted his younger brother with a hammer and was later apprehended by a police canine. On Monday (12/06) at 3:50 p.m., County Police responded to the aforementioned residence, which is located in the development of Rambleton Acres, for a report of a physical domestic dispute involving a hammer. When police arrived, they contacted the victim who reported that he was arguing with his older brother when he was pushed against a wall and then struck with a hammer. The investigation revealed that the victim and his brother were arguing over the use of a vehicle that belonged to their mother. During the argument, the victim was pushed into a wall and fell to the floor. As the victim stood up, his brother started swinging a hammer in his direction and struck him about his head and upper body. Amalfitano then fled the home on foot (with the hammer in his possession) in an unknown direction. he victim sustained minor scratches and abrasions to his face, chest and arms. Officer First Class Robert Vasecka and his canine partner "Vasu" responded to the scene and began tracking Amalfitano across the rear yard to an open gate at the driveway. He continued tracking out to Stevens Avenue and along the sidewalk before crossing the road and into the driveway of a residence in the unit block of Holden Drive. Amalfitano was then located in the home and taken into custody without incident. Amalfitano was arrested and charged with assault in the second degree, aggravated menacing and possession of a deadly weapon during the commission of a felony. He was committed to prison after failing to post \$10,000 secured bond.

## Verizon Van Located, Two Teens Arrested After Attempting to Flee



New Castle County Police have arrested two teens for receiving stolen property and related offenses after they were seen occupying a Verizon van that was reported stolen from the City of Wilmington earlier in the day. Both subjects were caught after fleeing from police. On Wednesday morning (12/22) at 8:45 a.m., Officer First Class Daniel Guzevich responded to the community of the Woodburne Townhouses after it was reported that a white Chevrolet Astrovan, which was marked with "Verizon" on the sides, had been tracked to the area of 24 Wildfire Lane. When Officer Guzevich arrived, he located the vehicle in the overflow parking lot in the vicinity of 52 Wildfire Lane. As Officer Guzevich pulled his patrol car behind the vehicle, he observed the driver's side door open and two subjects flee. A foot pursuit ensued and the suspects headed into a small wooded area between Wildfire Lane and Elks Trail. Officer Guzevich ordered the subjects to stop, but both suspects failed to comply and continued running until their escape route was eventually cut short by a stockade wooden fence. James Lawson, a 17 year old male who resides in the 200 block of Christiana Road in New Castle, stopped running and was taken into custody. Kenneth Dembey-Brown, a 16 year old male who resides in the unit block of North 35th Street in

the City of Wilmington, once again failed to comply with the officer's orders to stop and climbed over the fence. Officer Guzevich was able to reach over the fence and deploy his Taser. Dembey-Brown was then taken into custody. Dembey-Brown and Lawson were charged with receiving stolen property, conspiracy in the second degree and resisting arrest. Dembey-Brown was arraigned and issued a \$4,000 unsecured bail and released to his parents. Lawson was arraigned and issued a \$3,000 unsecured bail and released to his guardian.

# Four Teens Caught, Arrested for Multiple Thefts from Cars

New Castle County Police have arrested four teens and charged them with burglary and related offenses after police caught them breaking into vehicles in the community of Rambleton Acres. Early Sunday (12/26) morning at 2:30 a.m., County Police responded to the area of Holden Drive in the community of Rambleton Acres for a theft that just occurred. A concerned neighbor called 9-1-1 after they observed several subjects who were reportedly breaking into vehicles in the area. Police arrived within moments of the call and observed the suspects attempting to break into a vehicle on Stevens Avenue. When the officers attempted to contact the subjects, they fled on foot. Officer Jeffrey Snyder was able to locate one of the teens hiding under a porch of a nearby residence. A short time later, as Officer Wesley Neeman was conducting a property check, he located a suspicious vehicle (1993 Silver Jeep Cherokee) in a nearby parkland. He stopped

the vehicle on Balbach Road and discovered the car was occupied by two subjects. He then found them to be in possession of property that had just been stolen from several cars. Officers were able to locate the other teen that fled, as he was later observed attempting to break into another vehicle in the area. The officers have been able to identify at least four victims so far within the community. The following suspects were each charged with two counts of burglary in the third degree, two counts of attempted burglary, two counts of theft, four counts of conspiracy in the second degree and resisting arrest. They were all arraigned and released to their parents on \$2,750 unsecured bail. Michael Lynn, a 17 year old male, who resides in the 100 block of West Franklin Drive in the development of Wilmington Manor in New Castle. Zachary Robbins, a 16 year old male, who resides in the 300 block of Pennewill Drive in the development of Leedom Estates in New Castle. Renee Lightcap, a 16 year old female, who resides in the 800 block of Seymour Road in the development of Fairwinds in New Castle. John Morely, a 17 year old male, who resides in the 300 block of Pennewill Drive in the development of Leedom Estates in New Castle.
